
Interclub Council Committee Report

The feeling of fellowship in the Rotary Club and the satisfaction of giving service to others will be stressed in introducing the individual to Rotary. Questions by the proposed member will be invited and answered as fully as possible.

Approximately twice during the Rotary year, programs will be scheduled at the regular, weekly meetings of the Club to keep the membership posted on changes and additions to Rotary. The "Spoke" may be used for announcements at intervals, as required, and the Committee will stand ready to assist any member or committee which may have a query about the workings of Rotary International.

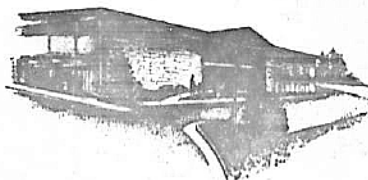

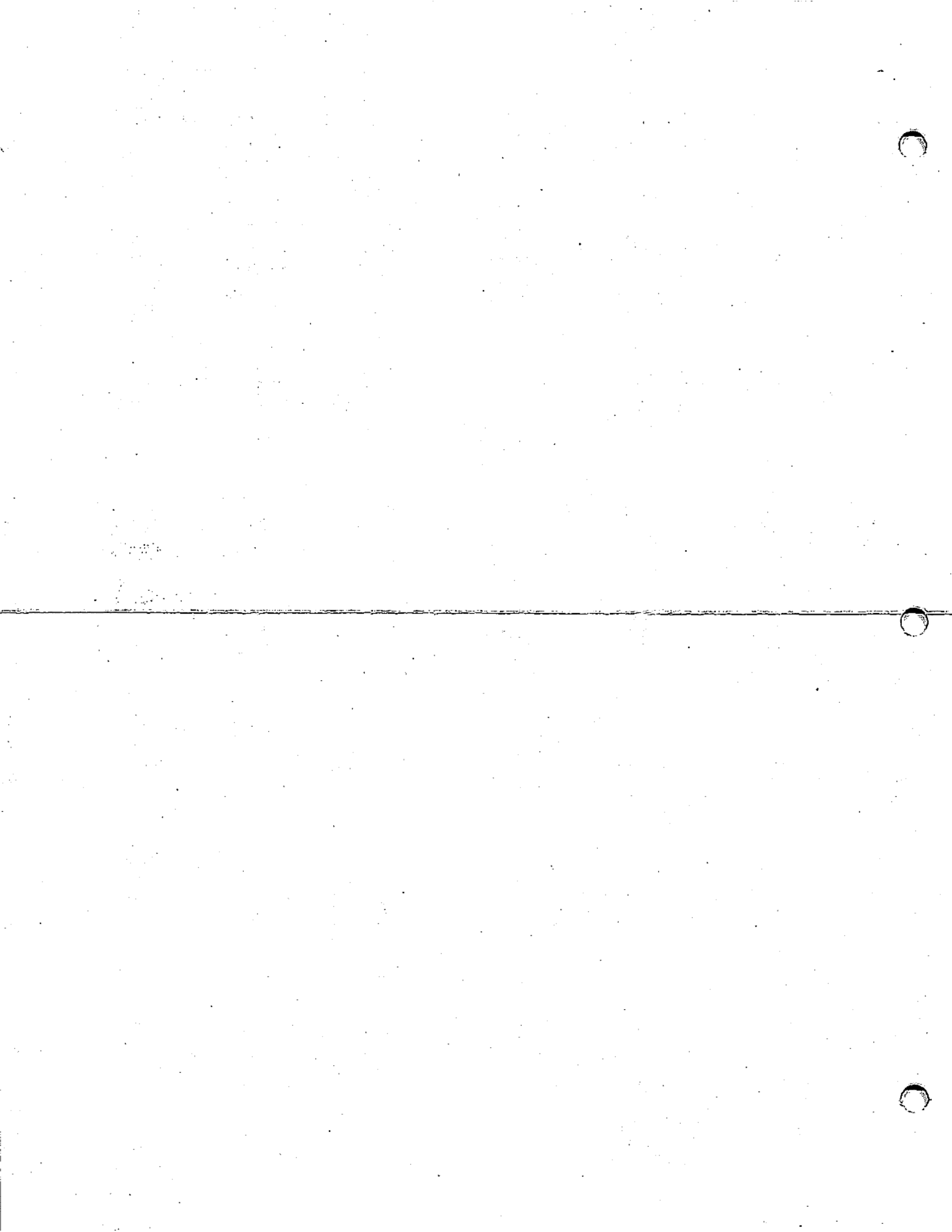

Your Cashier-Finance Committee will strive to furnish a dependable cashier each week and keep an accurate accounting of the meal tickets sold at all Rotary functions, whether it be at the regular weekly meeting place or some special event at another location.

We feel that our Committee can work in conjunction with the Fellowship Committee to help new members become more quickly acquainted with the rest of the group members by assigning the new members to the cashier table for a period of not more than one month.

At present, it is almost impossible to realize even a small excess from our luncheon fees, as Rotary is allowed only five cents out of each \$2.50 luncheon charge. If there is more than one guest of the group at any meeting, we automatically show a deficit. We would encourage any pressure your Board of Directors could initiate to have Rotary's share of the luncheon charge changed back to ten cents per plate.



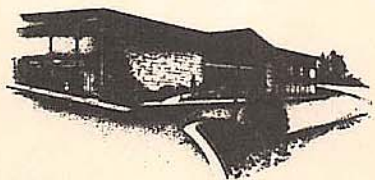

BLOOD BANK COMMITTEE**

In compliance with your recent request, the following represents a brief summary of the previous activities of the Blood Bank Committee and our future plans.

This committee was activated in 1964 and we have had six drives to date with a total of 281 persons arriving to donate. Our present account, as of this date, shows a total of 47 pints of blood to our credit. Our Board of Directors authorized this committee, as of action taken on March 23, 1967, to release two units of blood each, in behalf of our Club, to the Sequoia Hospital and the County Hospital, on a monthly basis for the use of those patients that they select who are unable, for one reason or another, to replace the blood that they have received. This has shown itself to be another avenue of useful community service and our Club is reflected favorably to those who are the recipients of this charitable act.

After the annual drives of 1964, 1965 & 1966, it was decided henceforth to embark on a semi-annual drive commencing last year. Our last drive was on May 3, 1968 and the next will be held on November 1, 1968. We have been successful in securing the support and sponsorship of the Inter-Club Coordinating Council on each occasion and thereby have joined together with all of the service organizations in the Redwood City area.

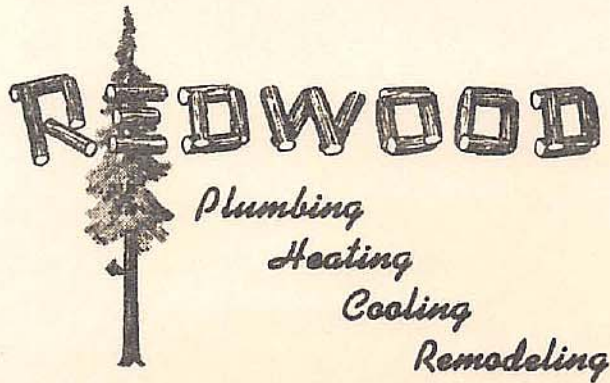

First, there is a great need to implement a program in the traffic safety field and the Safety Council needs some support in this area. We are going to launch an all-out drive to get people to sign up for the Defensive Driving Course, which will be taught this fall at both Menlo-Atherton Adult School and Sequoia Adult School. Both programs are in the hands of Rotarians - Bud fellows from Menlo-Atherton, and Alan Eastwick from Sequoia. The Council needs one more Defensive Driving Instructors Kit to teach this program, which will cost 1200. The program is expanding and the one kit we presently have will not cover the increase.

Information on another project is enclosed - the Congress Youth Sessions in Chicago. We have one outstanding student who received the Governor's Traffic Safety Conference Teenage Drivers Award, in second place, last December in Los Angeles. He is William Schmidt, who represented the San Mateo Union High School District in the driving contest, and he is the only teenager who received an award from our County. I believe he should be sent to Chicago to represent Redwood City Rotary and San Mateo County.

One other area of interest to me is to schedule approximately four speakers during the year to talk on some aspect of traffic safety. I am sure I can make arrangements for these.

Bob suggests that it would be in order for us to meet and review the trust fund portfolio and determine whether or not any changes are in order. Apparently this has not been done for several years.

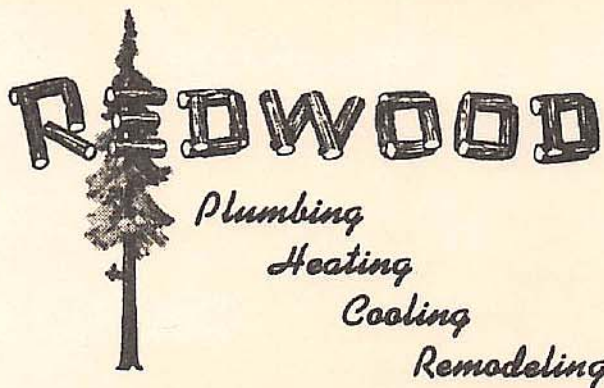

The following is a summary of the proposed objectives of the International Medical Project Committee of the 1968-69 Rotary year.

1. The continuance of collecting drug samples from San Mateo County Doctors.
 - a. Issue bulletins to all doctors asking them to continue donating drug samples for the above project.
2. Last year Dr. Moore began collecting used instruments for this project, and I will continue collecting them this year. As you know, an old portable X-Ray machine has already been donated.
3. At the present time there is about 100 cases drug samples and instruments stored at City Drug. Some are packed and sealed and ready for shipment, others have to be packed and sealed. I feel there should be at least 200 cases to make a shipment worthwhile.
4. There has been only one shipment of 197 cases of samples made in 1966 under your very capable chairmanship. My main objective for the year will be to have these drugs and instruments collected, packed, sealed and shipped by early spring of 1969.

The above outline will be carried out on a no cost basis therefore you will not have to budget any money for this project or committee.

I will submit a progress report early in 1969 and recommend some other projects that this committee may wish to ensue.





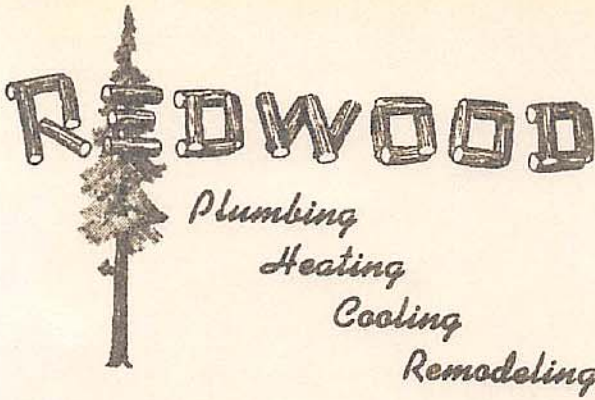
