Have you written that check for your dues? It's due, you know?

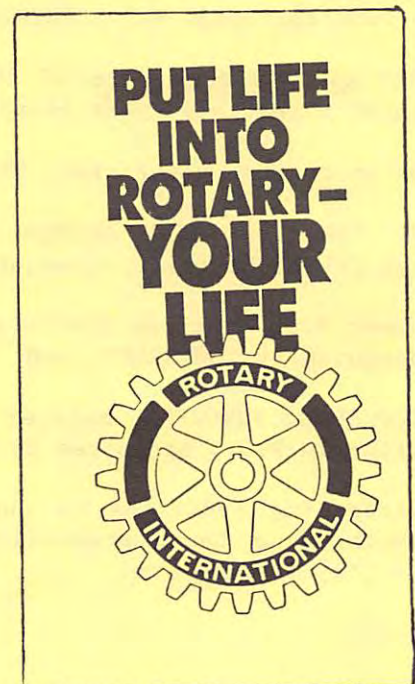
Don't forget the All Star Football game on the 30th in San Mateo. DENNIS has all the info. It deserves your support.

THE NEW R.I. POLICY ON VOCATIONAL SERVICE is the way Rotary fosters and supports the application of the ideal of service in pursuit of all vocations.

Inherent in the Vocational Service ideal are:

- 1) Adherence to, and promotion of, the highest ethical standards in all occupations, including faithfulness and fidelity to employers, employees, and associates, fair treatment of them and of competitors, the public, and all those with whom one has any business or professional relationships;
- 2) The recognition of the worthiness to society of all useful occupations, not just one's own or those which are pursued by Rotarians;
- 3) The contribution of one's vocational talents to the problems and needs of society.

Vocational Service is both the responsibility of a Rotary Club and of its members. The role of the Club is to implement and encourage the objective by frequent demonstration, by application to its own actions, by example, and by development of projects that help members contribute their vocational talents. The role of Members is to conduct themselves, their businesses, and their professions in accordance with Rotary principles and to respond to projects which the club has developed.

To reinforce the new emphasis on collective club efforts in this Avenue of Service, clubs are encouraged to set up subcommittees under the Vocational Service Committee in the following categories: 1) **Career Development**, 2) **Vocation at Work**, 3) **Vocational Awareness**; and 4) **Vocational Awards**.

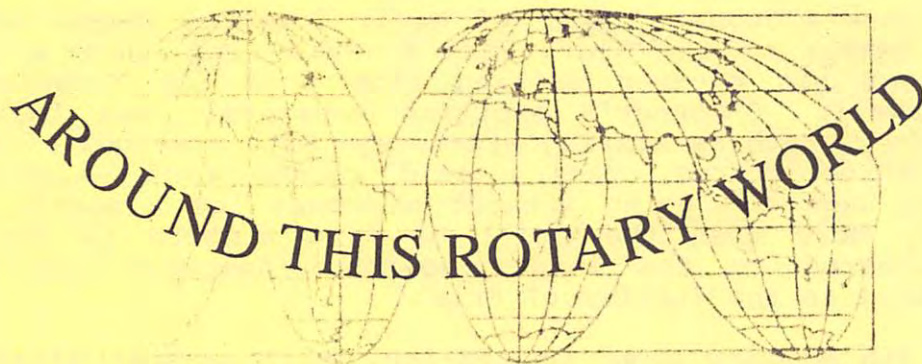

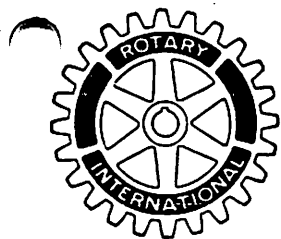

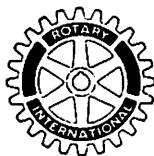

A first hand look at the state of affairs in this awakening giant of the east.

Pres. BOB led the pledge himself with ROLAND HAGA following with the invocation.

Board member BOB BOLAND conducted the fining session with recognition for enough "fivers" to please Treas. ERNIE.

BFTH FLSHBACK received a cuddly little bear from Pres. BOB for her work arranging for the scheduling of our three Japanese student visitors who were here for the first three weeks of August.

Past Pres. BILL, who did a lion's share of the housing and feed of our guests from Hiratsuka, had some harsh words for the club on the lack of participation and support by the membership in contributing towards the entertainment and hosting of these guests. The entire burden was picked up by little more than half a dozen out of a roster of over eighty - and that is, indeed, a pretty poor showing. 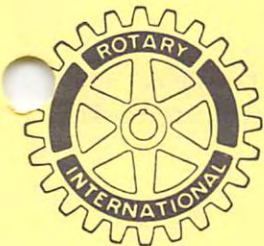

NIGERIA EYE CAMP: The Rotary Club of Redwood City can be proud of one of its most significant international service projects, the Nigerian Eye camp. It has taken since then (2 1/2 years) to bring to fruition. Sid proposed the project to our club for sponsorship during the term of Past Pres. BILL. Both BILL and SID took time off to provide the logistical and administrative elements of the project. In addition, countless hours were spent in preparation prior to the actual trip.

The project was a success with more than 200 cataract surgeries performed and more than 1000 eyeglasses dispensed. The goodwill generated for District 513 and Rotary in general cannot be evaluated. In addition to the surgeries at least two Nigerian Opthomologists were trained in microscopic surgery techniques and two surgical microscopes were donated to the Nigerias. One of the 'Scopes remains at the University of Ibaden and is equipped for teaching other Nigerian surgeons in the intricate art of microscopic interocular surgery. Well done RWC!

An interesting talk and further evidence of our substantial ignorance of Latin American affairs and problems.

OTHER VARIA: Pres. BOB says that Pres. Elect BOB STIFF will be heading up our delegation to this Rotary year's R.I. convention in Seoul May 21-24, 1989.

Registration and Housing request forms are included in the latest issue (October) of The Rotarian.

The next Peninsula Rotary Council dinner meeting will be held tomorrow evening the 26th at the Iron Gate in Belmont. For those attending it's cocktails at 5:30 and dinner at 6:30.

PAST PRES. BILL D.G. AREA REP: The following is a reprint of the DG's Newsletter interview with our Past Pres. BILL CONKLIN as to his current job as Area Rep:

IN THE LEAD: Rotary is important because it offers a possible chance to save the world. Things can happen because Rotary transcends politics and international boundaries. Through Rotary we can promote world peace. We can't do everything all at once. We can't save the world with one turn of the flapjack, but by doing little things, we can work toward understanding between nations. It's like a pebble that's thrown into a lake.... it causes just one little ripple, but it goes on and on.

I want to be an effective liaison to the district governor for the six clubs in my area, to help the established clubs remain strong - the best in the district - and to assist the two new clubs grow strong through increased membership, fundraising and committee operations. My experience should help, I've attended the last eight international conferences and dealt with some of the legislation. In the last five years I've been very active at district level, participating in assemblies, working on committees, and I have served as club chairman for the Foundation. These are experiences that members of a new club wouldn't have.

I would like to get the message across that the president-elect is probably the most important job in Rotary. the president has little time to do anything but to be the administrator of the club, run and prepare meetings, handle paperwork and coordinate the committees. the president-elect can do the little things that make the president look good, function as ombudsman, fill in wherever he sees a weakness.

Foundation to go with District funds, air tickets at cost arranged by Past. Pres. BILL - and on and on it goes - and finally, the direct participation of 9 including SID, BILL and 7 professionals such as R.C. Opthamologist DR. STANLEY GOLDEN in addition to Stanford's top eye surgeon, a Rotary Dentist and his wife as an assistant, a Rotary Optometrist and others all of whom will be gratefully acknowledged in the days and months ahead.

And, of course, financial support from our club as well.

Similar to 3-H is the Special Grants Program, whereby matching funds are provided for a club's financial gift earmarked for a specific international project. Such projects funded include health care stations and equipment, sanitation facilities and agricultural programs.

Rolling, cutting, and decorating Christmas cookies is a wonderful family tradition when children and friends become the production line.

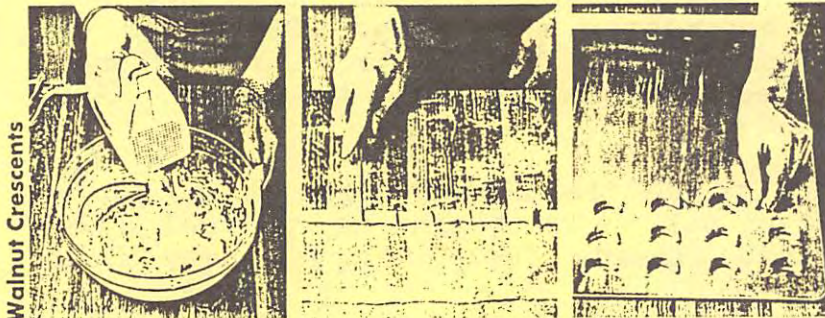
WALNUT CRESCENTS

prep 20 minutes / cook 35 minutes
plus 1 hour to chill (**)

- 1 cup (2 sticks) unsalted butter, room temperature
- ½ cup confectioner's sugar
- 2 tsp. vanilla extract
- Pinch salt
- 1¾ cups all-purpose flour
- ½ tsp. ground cinnamon
- 1 cup finely chopped walnuts
- ½ cup granulated sugar

1. Beat butter and confectioner's sugar in mixer bowl until light and fluffy (see p. 42). Add vanilla and salt and beat until blended. Sift flour and cinnamon together over batter and add walnuts. Mix on lowest speed until blended. Shape dough into ball and transfer to large piece of aluminum foil or plastic wrap. Wrap tightly; refrigerate 1 hour.
2. Heat oven to 325°. Lightly butter cookie sheets.
3. Divide dough into 6 pieces. Lightly flour hands and work surface. Roll each piece of dough into ½-in.-thick rope. Cut ropes into 1½-in. lengths. Transfer to prepared cookie sheets and shape into crescents, tapering ends slightly (see p. 42).
4. Bake cookies until set, 15-18 minutes. Cool slightly on cookie sheets. Roll warm cookies in granulated sugar and let cool completely on wire racks.

Makes about 5 dozen



Walnut Crescents

1. Bring the butter to room temperature and beat with confectioner's sugar in mixer bowl until light and fluffy.

2. With lightly floured hands, roll dough into ½-in.-thick ropes. Cut each rope into 1½-in. lengths.

3. Shape dough into crescents on prepared cookie sheet by gently curving and tapering ends.

Among the many faithful, Msgr. PETE and alumnus JERRY are sporting big grins over the Niner's Sunday Success. Now if only just one more time!

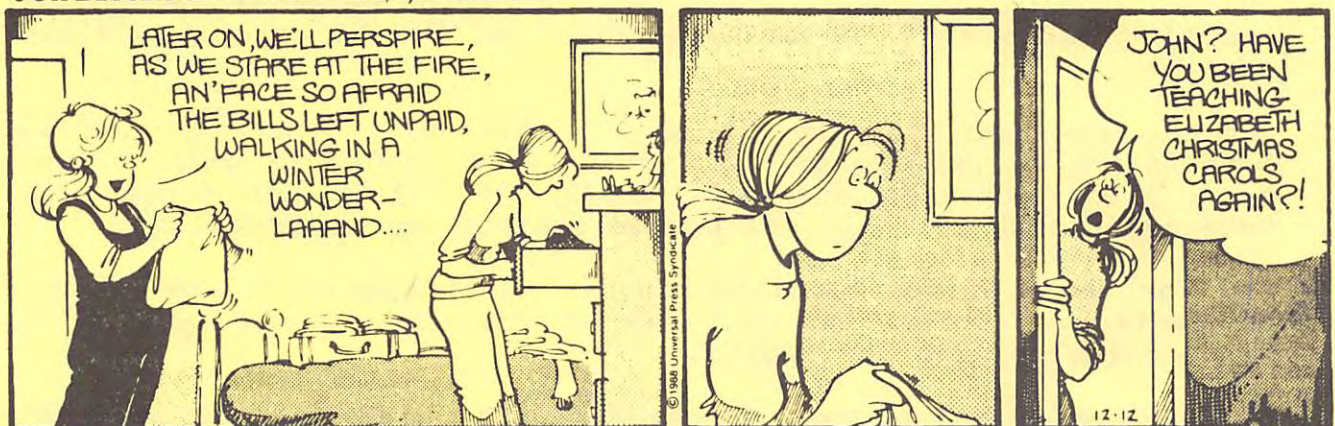

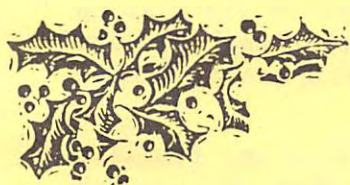
